**SITUATION VACANT**

Applications are invited from qualified candidates for appointment as **“Members of the Kerala State Commission for Protection of Child Rights”** as per the provisions of the Commission for Protection of Child Rights Act, 2005 (Central Act 4 of 2006), Kerala State Commission for Protection of Child Rights Rules, 2012 notified as S.R.O No.700/2012 dated 04<sup>th</sup> October, 2012 and amendment notified as S.R.O No.514/2014 dated 25<sup>th</sup> August, 2014.

**I. Number of Vacancy:** 2 (Two)

**II. Qualifications:**

(1) Candidates should be person of ability, integrity and should possess a minimum of 10 years experience in any of the following areas:

- (i) education;
- (ii) child health, care, welfare or child development;
- (iii) juvenile justice or care of neglected or marginalized children or children with disabilities;
- (iv) elimination of child labour or children in distress;
- (v) child psychology or sociology; and
- (vi) laws relating to children.

(2) He/She should not have any past record of violation of human rights or child rights.

(3) He/She should not have been convicted and sentenced for imprisonment of an offence which in the opinion of the Government involves moral turpitude.

(4) He/She should not have been removed or dismissed from service of the Central Government or a State Government or a body or Corporation owned or controlled by the Central Government or a State Government.

(5) He/She shall not be a Member of Parliament or be a Member of Legislature of any State and shall not hold any office of trust or profit. In case he/she carries on any business or practices any profession, he/she shall suspend as the case may be such business or practice before he/she assumes his office, if selected for appointment.

(6) Age: Must have completed 35 years and must not have completed Sixty (60) years as on 01.01.2022.

### **III. Term of appointment:**

The term of appointment of the Members will be three (3) years from the date of assumption of charge but not beyond 60 years of age.

### **IV. Remuneration:**

Members will be eligible for a fixed honorarium as allowance as fixed by Government from time to time.

Provided that if the Member is a retired Government Servant, his/her pay has to be fixed as per rule 100 Part-III KSRs.

If the Member is in the service of the Central Government or State Government his/her salary shall be regulated in accordance with the rules applicable to him/her.

V. Application along with the bio-data in the prescribed proforma appended herewith giving details of qualification, age, experience, etc and copies of testimonials/documents should be reached **before 5 pm on 21.03.2022** in the following address.

1. Appointment will be made by the Government of Kerala from among the candidates shortlisted on the basis of qualifications prescribed and as recommended by a Selection Committee constituted for the purpose based on merit and interview.

3. No TA/ DA will be paid for attending the interview.
4. Belated applications will not be entertained under any circumstance and such application will be summarily rejected without assigning any reason thereof.
